

How much does it cost?


Our representation is free if you have limited income and meet our case criteria.





THE VETERANS LEGAL CLINIC

In 2012, the Veterans Legal Clinic opened its doors to provide pro bono legal assistance to disabled veterans and their family members. Our goal is to protect the legal rights of the veterans community through determined, passionate, and effective advocacy.

TYPES OF CASES WE HANDLE

Veterans Benefits

We provide representation in appeals at all levels (agency and court) involving access to:

- Massachusetts Chapter 115 Veterans' Services Benefits
- Services Benefits

 VA service-connected disability compensation benefits
- VA pension benefits
- VA dependency & indemnity compensation (DIC) benefits
- VA healthcare

Military Discharge Upgrades

We provide representation before the military review boards and in federal court when a veteran unjustly received a less-thanhonorable discharge that causes continuing harm. We handle cases involving:

- Discharge upgrades
- Records corrections
- Changes to narrative reason and re-entry code

In addition to representing individual clients, the Clinic also pursues broader initiatives to improve the systems that serve the veterans community. As a teaching site of Harvard Law School, our advocacy team includes both experienced attorneys and second- and third-year law students.

Estate Planning

We assist veterans and their family members in a variety of estate planning matters:

- Wills and living wills
- Powers of attorney
- Health care proxies
- Guardianships and conservatorships
- Trusts and special needs trusts
- Probate of estates
- Qualifying for VA pension or MassHealth

Social Security Disability

We represent veterans before the Social Security Administration and in court when they have been denied Supplemental Security Income (SSI) and/or Social Security Disability Insurance (SSDI).

THE CLIENTS WE SERVE

We help veterans of all backgrounds and all generations, from World War II to the Post-9/11 era. We also help the family members of veterans. Our clients include LGBT veterans, women veterans, combat veterans, less-than-honorably discharged veterans, veterans who have experienced MST, and Guard and Reserve veterans.

What other types of cases does the Legal Services Center handle for veterans?

Student Loan Issues

If you attend or attended a for-profit school and have student loan problems, call us. We help clients fight back against predatory student lending.

IRS / MIA DOR Tax Issues

We assist with a variety of tax issues, including IRS audits, IRS appeals, Tax Court cases, and collection issues (including offers in compromise and installment agreements).

Starting or Running Your Own Business

Through our Veterans Enterprise Initiative, a collaboration with Harvard's Transactional Law Clinics, you may be able to get legal help to start or operate a small business including assistance with business formation, contracts, permits/ licenses, and leases.


What Services We Provide

The Veterans Legal Clinic provides free legal representation and advice to veterans who want a discharge upgrade or records correction.

We represent clients who seek to:

- Change the Character of Service or Discharge Status
- Change the Narrative Reason for Separation
- Appeal discharge-upgrade denials to records correction boards and to federal court

In addition, we represent less-thanhonorably discharged veterans in applications and appeals for health care or benefits from the U.S. Department of Veterans Affairs and the Massachusetts Department of Veterans' Services.



The Veterans Legal Clinic is part of the Legal Services Center of Harvard Law School. The Legal Services Center is a community-based law firm and a clinical teaching site for Harvard Law School.

Experienced attorneys and Harvard Law School students work together to represent low-income veterans and their family members for free.
