GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and Town affairs, to meet at the North Brookfield Elementary School Auditorium, in said North Brookfield, on Friday, the 1st day of November, 2013 at 7:00 PM, to act upon the following articles, namely:

ARTICLE 1

To see if the Town will vote to rescind a sum of money from the Group Insurance Account that was appropriated under Article 4 of the June 21, 2013 Annual Town Meeting, and further see if the Town will vote to raise and appropriate, borrow, or transfer from available funds, a sum of money to the Group Insurance Account, or take any action relative thereto.

ARTICLE 2

To see if the Town will vote to raise and appropriate, borrow, or transfer from available funds, the sum of \$95.00 to the FY 2013 Unpaid Bills Account, or take any action relative thereto.

ARTICLE 3

To see if the Town will vote to transfer the sum of \$2,954.00 from the Transfer Station Monitors Salary Account to the Transfer Station Bag Purchase Account, and further vote to transfer the sum of \$1,958.00 from the Board of Health Clerk Salary Account to the Transfer Station Bag Purchase Account, or take any action relative thereto.

ARTICLE 4

To see if the Town will vote to accept the sum of \$78,473.00 in additional Chapter 90 funds for FY14, or take any action relative thereto.

ARTICLE 5

To see if the Town will vote to rescind the sum of \$767.00 from the amount appropriated to the Bay Path Vocational School District budget under Article 4 of the June 21, 2013 Annual Town Meeting, or take any action relative thereto.

ARTICLE 6

To see if the Town will vote to rescind the authority to borrow \$248,000.00 for expenses associated with the Engineering and Construction of the Horse Pond Dam Project as voted under Article 1 at the May 7, 2010 Annual Town Meeting, or take any action relative thereto.

ARTICLE 7

To see if the Town will vote to raise and appropriate, borrow, or transfer from available funds, a sum of money to the Tree Maintenance Account, or take any action relative thereto.

ARTICLE 8

To see if the Town will vote to raise and appropriate, borrow, or transfer from available funds, the sum of \$1,450.00 to the Fire Department Purchase of Service Account, or take any action relative thereto.

ARTICLE 9

To see if the Town will vote to raise and appropriate, borrow, or transfer from available funds, a sum of money to purchase or lease 30 sets of Fire Department turnout gear, and to authorize the Board of Selectmen to enter into a lease or lease-purchase agreement of up to six years for such purpose, or take any action relative thereto.

ARTICLE 10

To see if the Town will vote to accept MGL Chapter 41 Section 108P allowing for a collector or treasurer who has completed the necessary course study and been awarded a certificate from the Massachusetts Collectors and Treasurers Association an amount equal to 10 percent of regular annual compensation but not more than \$1,000.00 per year, or take any action relative thereto.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of said meeting as aforesaid.
