# A. Review Town Meeting articles

The Board reviewed draft warrants for the May 6<sup>th</sup> Annual Town Election and the May 10<sup>th</sup> Special and Annual Town Meetings.

### B. Accept check from Charter Communications

Mr. Kiley read a letter from Charter Communications that accompanied a check for \$30,000 as the Town's annual PEG grant. Mr. Tripp moved, and Mr.Kiley seconded, a motion to accept the money. So voted.

### IV. OLD BUSINESS

#### A. CMRPC Traffic Count

Highway Superintendent Jason Benoit has requested that three streets be added to the Town's annual traffic count: Hillsville Road east of Ryan and Madbrook, North Street and Green Road.

### B. Landfill solar lease option

Mr. Kiley noted that the Selectmen did sign a 3 year lease option agreement with Symbiont Energy that will allow them to study the feasibility of installing solar panels on the former landfill. Either side can back out of the agreement at any time.

### A. Request for appointment to DDC

Mr. Kiley read a letter from Ethan Melad asking to be appointed to the Downtown Development Committee. Mr. Melad noted that he has attended many of the group's meetings and is looking forward to getting involved.

### C. Request for appointment to Housing Authority

Mr. Tripp read two letters from Ashlie Wolf and Sandra Ingemi asking that Ms. Ingemi be appointed to the Housing Authority. Mr. Tripp moved and Mr. Kiley seconded, a motion to appoint Ms. Ingemi. so voted.

## D. Friends of Town House request to use Town House

Mr. Kiley reviewed an e-mail from Trish Miller asking that the Friends of the Town House be allowed to give tours and use the upstairs hall during the May Day festival. The Friends will be attending next week's meeting to fully discuss their plans.
