# MINUTES OF SELECTMEN'S MEETING OCTOBER 17, 2017

Chairman Hevy called the meeting to order in the Senior Center at 6 PM with Mr. Petraitis also present. Mr. Kiley was not present.

## V. NEW BUSINESS

# A. Request to hire new Highway employee

Highway Superintendent Jason Benoit introduced Ron Barrows as his choice for the new CDL Driver/Laborer. Mr. Benoit noted that Mr. Barrows has been working part-time for the department, and will now go to full-time at a rate of \$17.72 per hour. Mr. Barrows stated that he grew up in North Brookfield, and has owned his own business for 25 years. Mr. Petraitis moved, and Mr. Hevy seconded, a motion to approve the appointment effective immediately. So voted.

## B. Request to hire new Sewer employee

Sewer Superintendent Rodney Jenkins introduced Eric Cardenas as the new Assistant Superintendent. Mr. Jenkins noted that he and the commissioners interviewed 4 applicants; 3 had Grade 5 licenses, and Mr. Cardenas has a Grade 6, which is the highest. Mr. Cardenas stated that he currently works in Spencer, and is looking forward to starting in North Brookfield. Mr. Petraitis moved, and Mr. Hevy seconded, a motion to approve the appointment effective October 30<sup>th</sup>. So voted.

## C. Fire Department monthly report

Fire Chief Joe Holway gave an update on what has been happening with the department since he took over September 1<sup>st</sup>. (Attachment #1) Chief Holway also presented an organizational chart of the department. (Attachment #2) Chief Holway noted that the Gregoire family of Rufus Putnam Road presented the relief association with a 60" TV in appreciation for the department's work fighting a fire at the Gregoire home. Mr. Petraitis moved, and Mr. Hevy seconded, a motion to accept the report. So voted.

## D. Highway monthly report

Highway Superintendent Benoit reviewed his departmental report for August and September. (Attachment #3) Mr. Benoit reported that he has split his crew in order to accomplish more work. He hopes to start his paving projects this week.

Mr. Hevy noted that there is vegetation that grows up at the Aztec property. It is all taken care of for this year, but going forward he would like the Highway Department to maintain it. Mr. Benoit indicated that it could be done. Mr. Petraitis moved, and Mr. Hevy seconded, a motion to accept the report. So voted.

# E. Request for bass tournament

Mr. Petraitis read a letter from Ray Lentine of Oxford asking for permission to hold a bass fishing tournament on Lake Lashaway on July 20, 2018. (Attachment #4) Mr. Hevy said that while he has no objections, Mr. Lentine should contact the East Brookfield Selectmen and perhaps even the Lake Association. Mr. Hevy said that he will call Ted Bouley of the East Brookfield Selectmen and also Mr. Lentine. Mr. Petraitis moved, and Mr. Hevy seconded, a motion to approve pending approval by East Brookfield. So voted.
