  - o Kathy motion, Chet second, unanimous
- FYI Transfers
  - BOH informational only
    - \$810 within expenses
- Old Business
  - Budgets
    - Fire Department
      - Assistant Chief Salary why do they have 3 chiefs?
        - Dale explained that there are 3 teams within a fire department and each team has a chief
        - Tara made a motion to not fund the Assistant Chief salary line item and to prorate it when the chief is ready to appoint; Michelle second, unanimous
    - Highway
      - Off Duty Police detail
        - Hasn't been used in a couple of years; highway can close the road to conduct work
        - Tara made a motion to not fund the Off Duty Police line item; Chet second, unanimous
    - School
      - Last discussed taking \$1M from FY21 appropriation
        - According to DESE the net school spending amount is \$3,100,851
      - Plan B?
        - o Is there a way to make up the \$1.3M?
          - School asked about a prop 2.5 override
            - That would increase an average of \$350/year
            - Elderly on fixed incomes can't afford
            - Would need a special town meeting and a special town election to pass
          - There is nothing to cut from other departments; any cuts made don't come close to meeting that gap
      - Discussion of the monies that the school will get
        - o \$4,308,000 from Chapter 70
        - \$5,100,000 from the town
        - \$1,900,000 paid by the town for benefits
        - o \$11,308,000 total
    - Can we get additional monies from the state or federal government to make up for the GGG money we didn't get because they were closed?
      - To be explored
    - There is talk about being able to get monies to replace the funds taken from our stabilization expenditures
      - To be explored
    - Revenue sources
      - Put lease stabilization funds into the spreadsheet for a revenue source
