TO ANY CONSTABLE OF THE TOWN OF NORTH BROOKFIELD

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and Town affairs, to meet at the North Brookfield Elementary School Auditorium, in said North Brookfield, on Friday, the 11th day of May, 2012 at 7:00 PM, to act upon the following articles, namely:

ARTICLE 1

To see if the Town will vote to transfer a sum of money from the Police Shift Differential Account to the Police Overtime Account, or take any action relative thereto.

ARTICLE 2

To see if the Town will vote to transfer a sum of money from the Library Salary Account to the Library Expense Account, or take any action relative thereto.

ARTICLE 3

To see if the Town will vote to transfer a sum of money from the Water Retained Earnings Account to the Water Expense Account, or take any action relative thereto.

ARTICLE 4

To see if the Town will vote to transfer a sum of money from the Sewer Retained Earnings Account to the Sewer Expense Account, or take any action relative thereto.

ARTICLE 5

To see if the Town will vote to transfer a sum of money from the Insurance Reimbursement Account to the School Expense Account, or take any action relative thereto.

ARTICLE 6

To see if the Town will vote to transfer a sum of money from available funds to the Police Part-time Salary Account, or take any action relative thereto.

ARTICLE 7

To see if the Town will vote to transfer a sum of money from available funds to the Police Overtime Account, or take any action relative thereto.

ARTICLE 8

To see if the Town will vote to transfer the sum of \$1,100.00 from available funds to the Highway Maintenance Street Signs Account, or take any action relative thereto.

ARTICLE 9

To see if the Town will vote to transfer a sum of money from available funds to the Snow and Ice Account, or take any action relative thereto.

ARTICLE 10

To see if the Town will vote to transfer a sum of money from available funds to the Fire Department Equipment Account to cover the cost of 30 pagers, or take any action relative thereto.

ARTICLE 11

To see if the Town will vote to transfer a sum of money from available funds to the Veterans Benefits Account, or take any action relative thereto.

ARTICLE 12

To see if the Town will vote to transfer any unexpended balances of FY2012 appropriations, hitherto made to other accounts, or take any action relative thereto.

And you are hereby directed to serve this Warrant by posting attested copies thereof in the Library and upon the Town House in said Town.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of said meeting as aforesaid.
