GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and Town affairs, to meet at the North Brookfield Elementary School Auditorium, in said North Brookfield, on Friday, the 8th day of May, 2015 at 7:00 PM, to act upon the following articles, namely:

ARTICLE 1

To see if the Town will vote to transfer a sum of money from available funds to the Snow and Ice Account, or take any action relative thereto.

ARTICLE 2

To see if the Town will vote to transfer the sum of \$11,605.00 from available funds to the Vocational School Tuition Account, or take any action relative thereto.

ARTICLE 3

To see if the Town will vote to transfer the sum of \$11,890.00 from available funds to the Vocational School Transportation Account, or take any action relative thereto.

ARTICLE 4

To see if the Town will vote to transfer the sum of \$4,000.00 from available funds to the Technology Expense Account, or take any action relative thereto.

ARTICLE 5

To see if the Town will vote to transfer the sum of \$32,017.00 from available funds to the School Expense Account, or take any action relative thereto.

ARTICLE 6

To see if the Town will vote to transfer a sum of money from the available funds to the Police Cruiser Account, or take any action relative thereto.

ARTICLE 7

To see if the Town will vote to transfer the sum of \$4,130.00 from available funds to the Fire Department Equipment Account, or take any action relative thereto.

ARTICLE 8

To see if the Town will vote to transfer the sum of \$4,000.00 from available funds to the Highway Line Painting Account, or take any action relative thereto.

ARTICLE 9

To see if the Town will vote to transfer a sum of money from the Police Salary Account to the Police Overtime Account, or take any action relative thereto.

ARTICLE 10

To see if the Town will vote to transfer a sum of money from the Police Salary Account to the Police Part-time Salary Account, or take any action relative thereto.

ARTICLE 11

To see if the Town will vote to transfer a sum of money from the Police Gasoline Account to the Police Other Account, or take any action relative thereto.

ARTICLE 12

To see if the Town will vote to transfer a sum of money from the Police Clerk Salary Account to the Police Overtime Account, or take any action relative thereto.

ARTICLE 13

To see if the Town will vote to transfer the sum of \$3,300.00 from the COA Program Assistant Salary Account to the COA Expense Account, or take any action relative thereto.

ARTICLE 14

To see if the Town will vote to transfer a sum of money from the COA Director Salary Account to the COA Expense Account, or take any action relative thereto.

ARTICLE 15

To see if the Town will vote to transfer the sum of \$900.00 from the Assessors Salary Account to the Revaluation Other Expense Account, or take any action relative thereto.

ARTICLE 16

To see if the Town will vote to transfer the sum of \$400.00 from the Zoning Board Clerk Salary Account to the Planning Board Clerk Salary Account, or take any action relative thereto.

ARTICLE 17

To see if the Town will vote to transfer a sum of money from the Water Retained Earnings Account to the Water System Improvement Account, or take any action relative thereto.

ARTICLE 18

To see if the Town will vote to accept the amount of \$46,931.00 in Winter Recovery Assistance Program funds, or take any action relative thereto.
