# MINUTES OF SELCTMEN'S MEETING OCTOBER 25, 2016

Chairman Walter called the meeting to order in the Senior Center at 6 PM with Mr. Hevy and Mr. Kiley also present.

# IV. FINANCIAL REPORTS

#### A. Review of October 24th meeting

The Selectmen reviewed the presentation that was given Monday night by the Collins Center at UMass Boston on their long-range financial forecasting and capital planning projects for North Brookfield. (Available in the Selectmen's office) This was done using funds from the Town's Community Compact with the state. Mrs. Walter noted that we have a lot of homework to do. The presentation offers a path to "wean" the Town from relying on Free Cash to balance the annual budget.

Mr. Kiley said that he was struck by how the lack of growth in commercial and industrial revenue has adversely affected the Town; it means that residents are footing the majority of the tax burden.

Mrs. Walter noted that the presentation will be available on the cable access channel.

Mrs. Walter also noted that last week she and other Town officials attended a conference in Framingham on using IT to improve local government. It was very informative.

#### B. Budget Policy and Calendar

The Selectmen reviewed the FY18 Budget Policy and the revisions that have been made. (Attachment #1) Mr. Hevy moved, and Mr. Kiley seconded, a motion to approve and sign the documents. So voted.

# VI. NEW BUSINESS

### A. Police Chief September report

Police Chief Mark Smith was present to review his departmental report for the month of September. (Attachment #2) The Chief reported that there were 30 incidents for the month with 14 arrests, summons and custody. Mr. Hevy moved, and Mr. Kiley seconded, a motion to accept the report. So voted.

### B. Memo from Insurance Advisory Committee

Mr. Kiley reviewed a letter from Treasurer Anne Jannette noting that the Insurance Advisory Committee has voted to recommend that the retiree insurance be renewed with Blue Cross Blue Shield and Fallon Senior Plan for FY2017. (Attachment #3) The Selectmen agreed that they would like to ask Mrs. Jannette why the renewals were not put out to bid. Leslie will ask the Treasurer to attend next week's meeting.

#### C. Highway request to spend Snow and Ice funds

Mrs. Walter read a letter from Highway Superintendent Gary Jean asking for permission to purchase salt from the Snow and Ice Account before November 1<sup>st</sup>. (Attachment #4) Mr. Hevy moved, and Mr. Kiley seconded, a motion to approve the request. So voted.

# D. Sign Cultural Council contract

Mr. Hevy reviewed a contract from the state for the Town's allocation of \$4,500.00 in Cultural Council funds. (Attachment #5) Mr. Hevy moved, and Mr. Kiley seconded, am motion to approve and sign the contract. So voted.

# E. Letter from Bay Path re: negotiations

Mr. Kiley reviewed a letter from Bay Path Reginal Vocational High School asking for a representative from the Selectmen to attend a meeting on November 7<sup>th</sup> to choose a municipal representative to attend bargaining sessions with the school's unions. (Attachment #6) Mrs. Walter said that she would be willing to attend.

Resident Doug Powers was present and asked the Selectmen to comment on any negotiations with the owners of a proposed marijuana facility on Prospect Street. Mr. Kiley said that the Board could not comment on any negotiations or planned

negotiations. Mrs. Walter noted that until the facility receives their permits and moves forward the Selectmen can't negotiate anything.

Mr. Kiley noted that host agreements can be used as an incentive to a developer. Is Mr. Powers asking if the Selectmen intend to negotiate a host agreement? Mr. Powers stated that he wants assurances that people other than the Selectmen will be involved in this. Mr. Kiley noted that the Selectmen have copies of host agreements from several other towns, and the Board will take the best of each and use them for the benefit of North Brookfield.
