# Local Rapid Response Grant

Ian asked about the grant, Ethan stated he had not been able to get in touch with Dale Kiley and Ashley regarding a signatory letter we needed to accompany the grant. We also have not heard from the state yet on the outcome of the grant itself.

### **New Business**

### Winter Shared Streets Grant

Ian and Gemma have joined us this evening to discuss the Winter Shared Streets program so that we can get a better understanding of the grant and how we might apply for it.

Overall, this is a grant that specifically targets temporary to permanent street projects that help to create spaces for the safety of the public both in a socially distancing and physical means. Projects that are encouraged include sidewalks, walkways, better traffic flow. Many of the projects in the NB Complete Streets Prioritization Plan have elements that could transfer easily into this grant.

The engineering and finished product of this grant needs to be done by May 2021. This is a "shovel ready" project. That being said, the DDC is not sure if we have that capability but we will continue to sift through the grant to see if it is applicable to our situation. Round 3 is due by January 29 an Round 4 (the final round) is due by February 26 with awards being acknowledged on March 26, 2021. These would come in the form of Ch 90 monies.

Some ideas for application included temporary "bump outs" at the intersection of North Main St where Summer and School Street meet. We also considered Jersey barriers on the North Side of North Main in front of the Congregational church to create a sidewalk, but that idea was

squashed as we didn't think it was a good idea due to the time of year as well as the already limited parking situation in the Downtown area.
