 - o Budgets
 - Police cruiser lease
 - The chief didn't include this on his budget; he thought it was paid by free cash. It was in the past but needed to be on the budget. It has been added it to the budget and the funds added to the Lease Stabilization Account. There was some discussion between Chet & Dale about leases not being included in department budgets. It was determined to move the lease payments to a separate category in the spreadsheet.
 - Highway Leases
 - The highway department leases will all be paid off in FY22.
 - Fire Assistant Chief salary
 - Tara found the minutes from the BOS meeting that set the salaries and did the math forward. \$6,767 salary has been entered into the budget.
 - School
 - Shiela continues to look for possible revenue. The school budget is now up to \$5,696,590, only \$462,590 less than level funded. There was much discussion about cutting all of the other departments. Most departments did submit lower budgets. Tara did the calculations for a 2% cut to every department which would save \$57,877. This would be set aside for any shortfalls we may experience this year. Chet made a motion that we notify all departments to cut 2% from the bottom line of their budgets except the school; Michelle seconded, unanimous.
