## **GREETINGS**:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and Town affairs, to meet at the North Brookfield Elementary School Auditorium, in said North Brookfield, on Friday, the 5th day of May, 2023 at 6:30 PM, to act upon the following articles, namely:

## ARTICLE 1

To see if the Town will vote to transfer the sum of \$30,362.33 from Free Cash, \$16,809.32 of which to be transferred to Highway: Snow and Ice Salt, \$9,057.99 of which to be transferred Highway: Snow and Ice Salary and \$4,495.02 of which to be transferred to Highway: Snow and Ice Gas, or take any other action relative thereto.

## ARTICLE 2

To see if the Town will vote to transfer the sum of \$1,723.57 from Highway: Snow and Ice Vehicle Repair to Highway: Snow and Ice Gas/Diesel, or take any action relative thereto.

## ARTICLE 3

To see if the Town will vote to transfer the sum of \$2,894.00 from Reserve Fund to Board of Selectmen: Sick Leave Buy Back or take any action relative thereto

## ARTICLE 4

To see if the Town will vote to transfer the sum of \$4,631.04 from Reserve Fund to Highway: Salary, or take any action relative thereto.

## ARTICLE 5

To see if the Town will vote to transfer a sum of money from available funds to Board of Selectmen: Town House Oil Heat, or take any other action relative thereto.

## ARTICLE 6

To see if the Town will vote to transfer a sum of money from available funds to Board of Selectmen: Technology, or take any other action relative thereto.

#### ARTICLE 7

To see if the Town will vote to transfer a sum of money from available funds to Board of Selectmen: General Insurance Account, or take any action relative thereto.

## ARTICLE 8

To see if the Town will vote to transfer \$1,500.00 from the Police Shift-Differential Salary account to Police Overtime account, or take any action relative thereto.

#### ARTICLE 9

To see if the Town will vote to transfer \$842.00 from Police Bullet Proof Vest Expense to Police Gasoline account, or take any action relative thereto.

#### ARTICLE 10

To see if the Town will vote to transfer \$4,000.00 from available funds to the Police Overtime account, or take any action relative thereto.

# ARTICLE 11

To see if the Town will vote to transfer \$4,247.00 from available funds to the Police Offices Expenses account, or take any action relative thereto.

## ARTICLE 12

To see if the Town will vote to transfer \$4,000.00 from available funds to the Police Gasoline account, take any action relative thereto.

## ARTICLE 13

To see if the town will vote to borrow, or transfer from available funds, \$5,000 for town fuel, or take any action relative thereto.

## ARTICLE 14

To see if the town will vote to borrow, or transfer from available funds, \$6,082 to Highway: Salary, to cover Union Contract negotiation wages or take any action relative thereto.

## ARTICLE 15

To see if the town will vote to borrow, or transfer from available funds, a sum of money for radio frequency expenditure for the Donovan Road Highway facility, or take any action relative thereto.

## ARTICLE 16

To see if the Town will vote to transfer a sum of money from Sewer: Retained Earnings to Sewer: Electrical, or take any action relative thereto.

## ARTILCE 17

To see if the Town will vote to transfer a sum of money from Sewer Clerk Salary to Sewer Solid waste disposal, or take any action relative thereto.

## ARTICLE 18

To see if the Town will vote to transfer a sum of money from Sewer Clerk Salary to Sewer Gasoline, or take any action relative thereto.

## ARTICLE 19

To see if the Town will vote to rescind the vote of the March 10, 2023 Special Town Meeting, Article 2, that transferred \$208,518.47 from Capital Stabilization to Highway: Equipment Outlay to pay costs of purchasing and equipping a tractor-mower, or take any action relative thereto.

## ARTICLE 20

To see if the Town will vote to transfer the sum of \$135,602.13 from Capital Stabilization to Highway: Equipment Outlay to pay for costs of purchasing and equipping a tractor-mower, or take any action relative thereto.
