GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and Town affairs, to meet at the North Brookfield Elementary School Auditorium, in said North Brookfield, on Friday, the 17th day of May, 2024 at 6:30 PM, to act upon the following articles, namely:

ARTICLE 1

To see if the Town will vote to transfer the sum of \$64.79 from Accountant: Other Expense to Accountant: Software Maintenance, or take any other action relative thereto.

ARTICLE 2

To see if the town will vote to transfer the sum of \$4,164.43 from Fire: Assistant Chief Salary to Fire: Equipment, to pay for the hydrotesting of all tanks for SCBAs, or take any action relative thereto.

ARTICLE 3

To see if the town will vote to transfer the sum of \$3,417.48 from Highway Snow and Ice: Vehicle Repair to Highway Snow and Ice: Salary, or take any action relative thereto.

ARTICLE 4

To see if the town will vote to transfer the sum of \$2,680.43 from Highway Snow and Ice: Vehicle Repair to Highway Snow and Ice: Diesel/Gas, or take any action relative thereto.

To see if the Town will vote to transfer the sum of \$250.00 from Town Beach: Purchase of Services to Town Beach: Electricity or take any action relative thereto.

ARTICLE 18

To see if the Town will vote to transfer the sum of \$5,000.00 from Town Beach: Purchase of Services to Playground & Recreation: Supplies, or take any action relative thereto.

ARTICLE 19

To see if the Town will vote to transfer the sum of \$25,000 from Water: Retained Earnings to Water: System Improvement, or take any action relative thereto.

ARTICLE 20

To see if the town will vote to transfer the sum of \$2,000.00 from Water: Retained Earnings to Water: Water Overtime Salary Account, or take any action relative thereto.

ARTICLE 21

To see if the town will vote to transfer the sum of \$7,000.00 from Water: Retained Earnings to Water: Chemicals Expense Account, or take any action thereto.

To see if the town will vote to transfer a sum of money from Sewer: Retained Earnings to Sewer: Electrical, or take any action relative thereto.

ARTICLE 24

To see if the town will vote to transfer a sum of money from Sewer: Retained Earnings to Sewer: Solids Waste Disposal, or take any action relative thereto.

ARTICLE 25

To see if the town will vote to transfer a sum of money from Sewer: Operator 2 Salary to Sewer: Testing and Research, or take any action relative thereto.

ARTICLE 26


To see if the town will vote to transfer a sum of money from Sewer: Operator 2 Salary to Sewer: Chemicals, or take any action relative thereto.
